The world of research is constantly evolving and high-profile expertise and professionalism need to be recognized. Selinus University's distance learning degree programs allow students to choose among many specializations, in order to work on their PhD thesis.

Any Doctor of Philosophy degree, either in science or in humanities, will attest graduates' deep knowledge and mastering of the chosen topic. The distance learning PhD degree is earned after successfully completing and defending the final doctoral thesis in the academic major of choice. The program is an effective way to strengthen students' cultural background and to foster new academic contributions in their knowledge field.

In order to be eligible for the program, students need to possess a Master's degree or equivalent and be at least 30 years old.

The main requirement for a distance learning Ph.D. by Research is to submit and defend the final thesis, which is required to have a minimum length of at least 90/100 pages. After the submission, it will be reviewed and evaluated by Selinus University's academic committee. In some cases, previous candidate's publications may be relevant for Ph.D. purposes.

The program has no minimum duration, whereas a maximum duration of 24 months. It does not have any intake or admission deadline; therefore, students can apply any time of the year.

The cost is all-inclusive: ongoing student support, general thesis supervision and evaluation, issuance and shipment of diploma certificate and transcript, degree authentication **via Blockchain technology**.

Selinus University cannot issue any scholarships, discounts or benefits whatsoever, because it is an international and private distance learning university, which does not have any system of institutions to rely on to issue any economic or financial benefits.

The student can pay in a single lump sum (with a 10% discount on the total price) or can split the fee payment into monthly and consecutive interest-free instalments. Further details on payment terms and conditions are available in the Application Form. In case of successful enrolment, the first payment deadline will be scheduled within 10 days from receiving the Enrolment Certificate.

Unlike any other traditional campus-based Ph.D., Selinus University's Ph.D. by Research **does not consist of any coursework, classes or lectures to attend, either on campus or online**.

Rather, it is based on independent and autonomous theoretical research on a specific academic area that the student has to carry out and implement in a final thesis.





As we are a distance learning university and our students come from all over the world, the thesis defense has to be submitted by email after the thesis approval.

The student can choose one of the following options to defend his/her thesis:

1

Written defense (to be sent via email)
a 3-5 pages paper, in which the student debates and displays his/her main argumentations, showing how he/she has achieved the prefixed academic goal.

2

Oral defense (to be sent via email)
a 15'-20' audio or video recorded presentation, in which the student debates and displays his/her main argumentations, showing how he/she has achieved the prefixed academic goal.

Accreditation - Education Quality - Reputation

The accreditation process is non-governmental and discretionary. A distance education university usually appeals to a private, regional or professional association, in order to be accredited. When any university applies, the accrediting institution performs an overall assessment and grants the accreditation only when deemed appropriate, according to its own accreditation criteria. No worldwide accreditation standards are currently available for any distance learning higher education institutions such as Selinus University.

A distance learning degree can be useful for many purposes, but not for all. It can give access to many careers and jobs, whereas others require government-accredited diplomas.

For this reason, before enrolling, we suggest our potential students to verify the correct degree use in their country.

Professional reputation depends on people's skills and competency, that are only virtually represented by the obtained degree. It is therefore necessary to bear in mind that any company or employer relies more on actual knowledge and expertise owned by aspiring employees, rather than on their degree. For most companies, the completion of a distance university program is as valid as attending courses in a formal university campus.

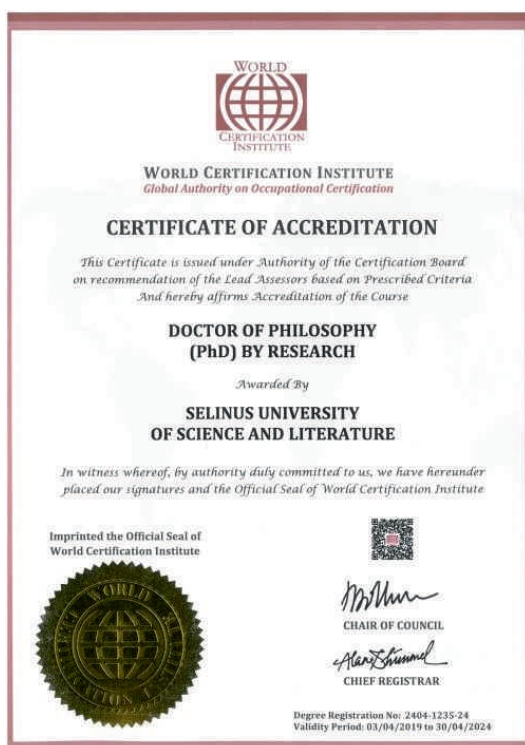
Selinus University of Science and Literature has the WCI (World Certification Institute) accreditation

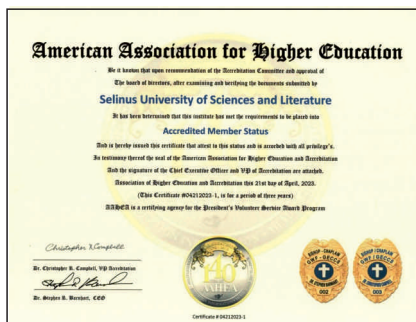

NOTE

Sometimes, our students - that are managers, professionals or entrepreneurs - need to obtain licenses or to transfer academic credits to/from other institutions. However, in the United States many licensing authorities require accredited degrees as a basis for issuing licenses. Therefore, the recognition of non-accredited university degrees, either for academic or professional purposes, may be discretionary.

In the event that a potential student wishes to enroll at Selinus University in order to access a governmental or public job or career, we recommend that the requirements are ascertained beforehand with the relevant authorities by the candidate, to assess whether the degree is useful or not for the desired work purposes. Selinus University does not intervene in such verification process.
